OCSCC No. 975 Financial Operating Summary June 2017

Revenue

Currently OCSCC No. 975 has invoiced 100% of the budgeted revenue. This month we also received payment from Linden for 1st year shortfall as agreed upon.

Expenses

Utilities are trending below budget however Hydro is high but we are still expecting some reprieve from the rebate in the coming months. It will be higher during this period due to cooling requirements and high humidity this year.

Monthly cleaning expenses, parking patrol and fire protection (monthly fire alarm test) are over budget this month and we expect this expense to be over budget for this fiscal year - cleaning was not accrued but our accounts department is still working on the process. We should have it corrected and running normally by next month.

We had a generator test completed for load testing for TSSA as part of the HVAC contract.

General Maintenance is under again this month as a result of restricted spending and ongoing Performance audit work from the developer.

Conclusion

Currently we are trending slightly over budget so far for this fiscal year. Due to several expenses being over budget we need to be caution of additional spending and take measures to reduce costs to not end this year in a deficit position.
