Revenue

Expenses

Gas, Hydro and Water are all under budget due to adjustments done by Colonnade. This will definitely help us this year and in subsequent budgeting. Shared Facilities is well under budget. This is a good sign as we are seeing the results now of good SF management and budgeting.

Contracts are under budget due to good budgeting and removal of HVAC contract. Tri Sorter maintenance contract is out of order. I found a mis coded invoice and this will be changed on next months report. Tri Sorter Maintenance will be back in line.

So far this year general maintenance is above budget due to the fire testing numbers we have been carrying for most of the year.

Legal costs are higher due to a couple of questions sent to lawyers.

All in all we are under budget and looking good for a surplus this year.
